



LETTER OF INTENT

between

THE RADIO AND TELEVISION SUPREME COUNCIL

and

MALAYSIAN COMMUNICATIONS AND MULTIMEDIA COMMISSION IN THE FIELD OF AUDIOVISUAL MEDIA SERVICES

The Radio and Television Supreme Council of Türkiye (RTÜK) and The Malaysian Communications and Multimedia Commission (MCMC) hereinafter referred to individually as the "Participant" and collectively as the "Participants", subject to national laws, rules, regulations and national policies of the Participants' countries, hereby sign this Letter of Intent for the purpose of fostering international cooperation and relationship between the Participants and in consideration, the Participants intend to;

- a. enhance and strengthen the close cooperation between them and contribute to increase efficiency and effectiveness in fulfilling their competencies entrusted to the Participants as the regulatory bodies by their national authorities;
- b. postulate exchange of experience, information, skills and knowledge through mutual activities and cooperation between Participants as their respective the national regulatory bodies in the field of audiovisual activities;
- c. increase the level of understanding and implementation of the international audiovisual standards and provide their contribution to the mutual understanding and the democratic processes and promotion of the cooperation between the Participants; and
- d. take the appropriate measures to sustain the culture of cooperation and experience-sharing developed within the OIC Broadcasting Regulatory Authorities Forum (IBRAF), which has the status of Affiliated Institution and Audiovisual Observatory in the Organisation of Islamic Cooperation (OIC).

This Letter of Intent serves as an instrument to record both Participants' intention to explore future cooperation outlined above. This Letter of Intent not be deemed to constitute a legally binding agreement between the Participants under International or their respective domestic law nor a binding international agreement or treaty and it does not create any legal rights or obligations for the Participants or the States of the Participants.

This Letter of Intent will not impose any financial obligations on either Participants. Each Participants will be responsible for its own costs, fees and expenses incurred in performing its respective commitments as intended under this Letter of Intent. Any arrangements or dealings, pursuant to the performance of this Letter of Intent, which may involve financial implications will be decided mutual agreed by the Participants and will be reduced into a separate definitive written instrument.

The foregoing represents the understanding reached between the Participants on the matters referred to in this Letter of Intent.

SIGNED at Putrajaya on this III day of February in the year 2025 in two (2) original texts each in the English and Turkish language, with all texts having equal validity. In the event of any divergence in interpretation between any of the texts, the English text will prevail.
